

# More construction on the way!

Construction is never easy for patients and staff, but we hope this last round of improvements provides welcomed changes and process enhancements for everyone. The greatest inconvenience will be updates to the lobby. Our goal is to have an efficient and friendly check-in area with warmth, privacy and plenty of seating. We are hoping to eliminate the numbering system and prevent confusion and lines.

Our intent is to move the phlebotomy and lab to the first floor for greater convenience to patients. We will be using the lab space on the second floor for more space for our physicians and advanced practice staff (nurse practitioner and physician assistants).

We will be creating beautiful space on the third floor for our Cancer Rehab Services, as well as our social work and nutritional counseling. Stay tuned for more updates. Construction will likely begin around summer and take 18—20 months for completion. A warm thank you in advance for your support during all our construction phases!

#### **Advance Directives**

## Let your wishes be heard



Regardless of your diagnosis, your age, or other factors, all patients have the right to and are encouraged to make their wishes formally known through the preparation of advance directives. While it is particularly important to have a plan and to have advance directives in place for those with terminal illness, it is encouraged that everyone has a medical plan and has defined their wishes, should there be a time in the future when you are unable to express those wishes for yourself.

**O**ur staff at HOA has the utmost respect for every one of our patients and we are honored to be a part of your journey. We always strive to help our patients maintain their *dignity*, and understand this can be difficult as the end of life approaches. Advance directives are one way to ensure that your wishes will be known and respected. It can be difficult to discuss advance directives, but once again, *we are here to help*. Our providers have honest and respectful conversations with patients and their loved ones, and our social workers provide additional assistance and support during these often confusing and difficult times; *you are not alone*.

#### ~ Understanding Advance Directives ~

- **Health Care Proxy**: A health care proxy allows you to appoint someone to make medical decisions for you (should you be unable to make your wishes known). Your designated Health Care Agent should be someone close to you that you trust and you should discuss your wishes with this person.
- **Living Will**: A Living Will details specifics about your medical treatment wishes. If you were to become seriously ill, your living will would guide your healthcare team and lets them know exactly what types of interventions you would like or which interventions you do not want done.
- ❖ **Do Not Resuscitate (DNR) Order:** A DNR will prevent healthcare practitioners from initiating emergency procedures in attempt to resuscitate you should you stop breathing or your heart stop beating. A DNR can facilitate a *natural death* for terminally ill patients.
- ❖ Medical Orders for Life Sustaining Treatments (MOLST): The *bright pink* MOLST form outlines end-of-life wishes for terminally ill patients. This form is completed with your doctor and should stay with you at all times (keep it readily available at home and bring it with you to hospital visits, etc.).



## Do you know your coverage benefits?

### Insurance Companies mandate the use of **Specialty Mail** Order Pharmacies - What this means for you!

Some payers are moving injectable drugs from coverage under your medical benefits to your pharmacy or specialty mail-order pharmacy benefits.

This change in benefit coverage could create a delay in your medical treatment, how you receive your treatment, and could be a higher cost to you and your employer.

## When a payer mandates the use of a specialty mail-order pharmacy it's known as Brown or White Bagging-

Brown and White bagging is the method of delivery by which physician- administered drugs are dispensed by a mail-order pharmacy for a specific patient, shipped to the patient (brown bagging) or to the physician (white bagging) for administration, and generally paid under the pharmacy benefit rather than the medical benefit.

This mandate has been shown to increase health care costs, as drugs are shipped ahead of time and may never be given due to changes in therapy, dose, duration or other unforeseen issues. Medications from mail-order pharmacies are shipped only for you and they cannot be used for anyone else. If your medication has been ordered and your treatment changes, it cannot be returned to the mail-order pharmacy for a refund. This means that you, your employer and your insurance company have paid thousands of dollars for medication that will have to be thrown out.

The responsibility and liability for purchasing, mixing, and administering injectable medications resides solely with HOA. For your safety and the safety of all our patients, the legitimacy of original drug sources and the appropriateness of subsequent storage and handling must be assured by us.

HOA opposes the action of payers that require practices to obtain and receive injectable drugs from a vendor mandated by the payer.

Please help us help you! Know your benefits, talk to your employer's human resources department and ask how your benefits are administered. We are here to advocate for you! If you have any questions please ask to speak with one of our patient advocates.
